Sub: Introduction of Customs Brokers Licensing Management System (CBLMS) – Reg.

Attention of all the Customs Brokers is invited to the newly introduced Online Portal called Customs Brokers Licensing Management System (CBLMS) that can be accessed through <https://cblms.gov.in>.

2. As part of CBIC's endeavour to digitize its business processes and enhance trade facilitation and ease of doing business, aforementioned CBLMS portal has been developed and designed. This portal will be the central platform for managing the entire spectrum of Customs Brokers' licensing processes with end-to-end IT integration and smart automation. The CBLMS Portal is launched with an aim to minimize the physical interface, bring uniformity in procedures and practices across all the customs formations in the country, process applications digitally and on time and to bring in accountability. With the implementation of CBLMS, the process of management of the Customs Brokers will become completely online.
3. As a first step, it has been decided to implement the **CB Profile Module** of the CBLMS Portal which entails the integration of data of existing Customs Brokers in the CBLMS portal. The CB profile module has gone critical pan-India on 14.10.2022.
4. In this context, all the Customs Brokers who were issued licenses by the Principal Commissioner/ Commissioner of Chennai Customs Zone are requested to create their profiles on CBLMS portal vide the Link: <https://cblms.gov.in>. Login ID and Password for logging in to the portal are being shared with all the eligible customs brokers on their mobile numbers registered with ICEGATE.
5. A detailed user manual for creating Customs Brokers' Profile is available on "Help Desk" Tab in the CBLMS portal, which can be accessed vide URL <https://cblms.gov.in/User%20Manual.pdf>.

Creation of profile of the Customs Brokers on the CBLMS portal being of paramount importance for smooth transition into the online system of Customs Brokers license management, a centralized CBLMS Helpdesk has been set up at the Taxpayer's Facilitation Cell, Ground Floor, Ganga Block, Custom House, Chennai – 600 001 to resolve any issues faced by the Customs Brokers on the CBLMS portal. Alternatively, the Customs Brokers may also send an email highlighting the specific issues being faced by them on the dedicated email id dc-cbschennai@gov.in or call the helpdesk number 044-25254574.

7. In light of the above, all the Customs Brokers working under Regulation 7 (2) of CBLR, 2018 and corresponding provisions of erstwhile regulations, under the jurisdiction of Chennai Customs Zone are requested to create their profile on the CBLMS portal latest by 31st of October 2022.
